Dear Sirs,

As you are probably aware, from 1st July 2013, all materials / products, which fall under the Constructional Products Directive, must comply with the relevant CE Marking Standards for Structural Steels. This is a mandatory requirement in all European member states for construction products.

All product derivatives also need to be compliant and all documentation supplied needs to meet / conform to the harmonised product standards.

As a supplier to the Klöckner Group, we ask you to provide the following for all European countries :

- Please supply a valid CE certificate conforming to EN1090
- Please supply a 'Declaration of Performance' (DOP) for all CE marked products as required by EN 1090.
- If you don't currently conform, please indicate when you will be compliant.
- Please confirm that all goods supplied will carry a 3.1 certificate to EN 10204, to be supplied to us either before delivery or accompanying the goods.
- Please note that it is also your responsibility to inform us should there be any non-compliance to these requirements after 1st July 2013, and on an on-going basis thereafter.

We trust that you understand the importance of these requirements and the need for us to plan for the 1st July 2013 in ensuring our supply chain is compliant. As such, we request a response by latest 15 July 2013 .
